1 - SUBJECT OF THE CONTRACT: The leasing of the mentioned buses to the LESSEE with drivers on the specified dates.

2 - CONTENT OF THE CONTRACT: This contract covers the commitments of the parties and the conditions of leasing the vehicle with a driver.

3 - COMMITMENT LETTER: The BUSKIRALA and LESSEE, acting as the contracting parties, have mutually undertaken and accepted their obligations to each other as stated below by signing.

4 - CONTRACT CONDITIONS: LESSEE will pay ...490USD..... to the BUSKIRALA. If there is a remaining amount, the remaining amount will be paid before the trip is completed. LESSEE may terminate the contract



without giving any reason. In case of termination by the LESSEE, no refund will be made. If BUSKIRALA terminates the contract, the prepayment paid will be refunded.

5- The costs of the traffic and comprehensive insurance of the vehicle belong to the BUSKIRALA.

6- The BUSKIRALA will deliver the vehicle with all functions operational to the LESSEE with a driver.

7- The BUSKIRALA is responsible for organizing the driver of the leased vehicle dressed in a white or blue shirt and tie until the completion of the job.

8- The cleanliness of the leased vehicle will be arranged by the BUSKIRALA on a daily basis.

9 -Any expenses related to malfunctions, maintenance, and repairs that may occur in the vehicle from the contract date onwards are the responsibility of the BUSKIRALA. No fees will be charged to the LESSEE regarding these expenses.

10 - The contract fee is calculated per vehicle ...600km..... If the leased vehicle exceeds the specified mileage, an additional fee of ... 2USD..... per kilometer will be charged separately for each kilometer for each vehicle.

11- The leased vehicle related to the contract will be ready at the specified address at the time indicated by the LESSEE on 05/04/2026The rental service will end on 12/04/2026 If the vehicle is not delivered to the BUSKIRALA at the specified time and date, an additional fee of 300USD per day and 2USD per kilometer will be invoiced.

12- In case of delayed delivery due to possible malfunctions in the vehicle, the BUSKIRALA cannot demand an additional fee and is responsible for resolving the malfunction as soon as possible.

13- In the event of any disruption of service by the BUSKIRALA for any reason, the BUSKIRALA is obliged to offer two options to the LESSEE. The first option is the same-day refund of the collected fee. The second option is to continue the service with a substitute vehicle.

14- If the leased vehicle is used in any illegal transfer service, all responsibility lies with the LESSEE. All fines, sanctions, and payments that may arise due to illegal travel are the responsibility of the LESSEE.
